1. Eligibility

- Open to Cameroonian citizens and legal residents.
 - Categories:
 - **Bounce Jam 237 (Dance):** Ages 9–30
 - **Vocal Vibes 237 (Singing):** Ages 9–35
 - **Laugh Out Loud 237 (Comedy):** Ages 18+
 - **The Ndjoka Show:** Ages 9-35
 - Participants under 18 must submit a **signed Parental Consent Form** (see Section 9).

2. Submission Requirements

- All entries must:
 - Be original performances.
 - Comply with format:
 - Be submitted via the official form on www.rr237media.com/talentseries or via WhatsApp (+237 679 154 674).
 - Include the intro line: “I’m [Name] from [City] for #[ShowHashtag]”.
 - Be submitted **with signed legal forms** (this document and parental consent if applicable).

3. Intellectual Property & Rights

By submitting content: - You grant R&R 237 an **exclusive, royalty-free, worldwide license** to reproduce, broadcast, distribute, edit, and monetize your content on any platform. - R&R 237 reserves the right to use entries for promotional, educational, or broadcast purposes. - Participants retain ownership of their original content but waive any compensation claims for its use in the competition.

4. Selection & Judging

- Public voting (social media engagement) determines shortlisting.
 - Live performances judged by a panel (40%), crowd reaction (30%), and online/SMS votes (30%).
 - R&R 237 may disqualify entries that violate content standards, contain hate speech, or show manipulated views/likes.
